

The Party No. 1 enters into this agreement with the Party No. 2 subject to the under mentioned terms and conditions:





The faculty members of Annamalai University will also be involved in teaching and project guidance on request. A minimum of 80% attendance by the students is compulsory for all the programmes.


The Party No. 1 and Party No. 2 will mutually chart out the scheme of examinations for the programmes each year.
